Frequently Asked Membership Questions

- ❖ *What is included in a Hitters Tennis and Pickleball Club Membership?*
 - Access to open court time, permanent court time and Open Play at no charge.
 - Access to our cardio fitness area and use of our locker rooms and amenities.
- ❖ *Are all PICKLEBALL court fees Included with membership?*
 - Yes, all Pickleball court fees, permanent time fees and Open Play fees are included with membership.
 - Pickleball lessons are additional fees.
- ❖ *What are the beginning and end dates for the membership year?*
 - September 1 through August 31. All memberships will automatically renew each year on September 1st unless resigned.
- ❖ *May a member join for a period of time less than the 12 month contract?*
 - Membership begins on the day in which the membership application was signed through August 31st. General Manager has discretion in cases of serious injury or illness as well as instances in which an out of the area move is required.
- ❖ *May a new member join at anytime?*
 - Absolutely. Membership would be valid and binding beginning on the date in which the member application was signed through August 31st. Dues will be prorated accordingly for the first month of membership.
- ❖ *Can Pickleball members access tennis courts and tennis lessons.*
 - No, Pickleball memberships are separate from tennis memberships. Please refer to the tennis membership application if you would like to participate in tennis and Pickleball.
