- ❖ Membership is valid and binding for one year beginning on September 1<sup>st</sup>, 2017 or on the date of completing this membership application through August 31<sup>st</sup>, 2018. All memberships will automatically renew on September 1<sup>st</sup> of each following year until membership is resigned by emailing the GENERAL MANAGER at: [joel@hitterstennis.com](mailto:joel@hitterstennis.com) by August 31<sup>st</sup> of the current year. If member fails to resign membership by August 31<sup>st</sup>, member will be liable for all membership dues for the following season which runs from September 1<sup>st</sup> through August 31<sup>st</sup> of each year.
- ❖ A re-instatement Initiation Fee will be applied to returning members who have previously resigned in the amount of the following: 10U Members \$100.00; Junior Single \$300.00; Adult Single, Adult Senior, Couples \$500.00, Families \$750.00

## Frequently Asked Membership Questions

- ❖ *What is included in a Hitters Tennis Club Membership?*
  - Access to open court time at no charge as well as exclusive access to our lesson and league program.
  - Adult, Senior, and Family Members have full membership to Hawks Landing Tennis Club outdoor tennis facilities.
  - Access to our Cardio Fitness Area.
- ❖ *Do I need to be a member to take lessons?*
  - Yes.
- ❖ *Can non-members reserve courts?*
  - No.
- ❖ *How long is the membership year and what months comprise of the membership year.*
  - September 1 through August 31.
- ❖ *May a potential member join for a period of time less than the 12 month contract?*
  - Membership begins on the day in which the member application was signed through August 31st. General Manager has discretion in cases of serious injury or illness as well as instances in which an out of the area move is required.
- ❖ *May a new member join at anytime?*
  - Absolutely. Membership would be valid and binding beginning on the date in which the member application was signed through August 31st. Dues will be prorated accordingly for the first month of membership.
- ❖ *Is access to the Batting Cages included with a Hitters Tennis Club membership?*
  - It is not included. Tokens may be purchased at the front desk.
- ❖ *Can parents of junior players play with their children on the courts?*
  - Yes, but they must be registered as a guest if they are not a member. Each guest may play up to 5 times per year at a cost of \$15.00 per visit.
- ❖ *What type of Court Time is included with membership and how often can members book a court?*
  - Each member may reserve up to 1.5 hours of court time per day when available. Courts may be booked up to 7 days in advance.
  - Members may join our annual ball machine program or pay a daily ball machine fee.  
Individual Ball Machine Fee = \$50.00, Annual Family = \$99.00, Daily Fee = \$5.00
- ❖ *Is Pickleball included with a tennis membership and can members book Pickleball court reservations?*
  - Hitters membership includes free Open Play Pickleball for ages 14 & Up.
  - Pickleball courts can be reserved by contacting the front desk.
