- ❖ *What is included in a Hitters Tennis and Pickleball Club Membership?*
  - FULL ACCESS TO OUR FANTASTIC NEW OUTDOOR PICKLEBALL FACILITY AT HAWKS LANDING!!
  - Access to open court time at no charge as well as exclusive access to our lesson and league program.
  - Access to our cardio fitness area and use of our locker rooms and amenities.
- ❖ *Are all PICKLEBALL court fees Included with membership?*
  - Yes, all Pickleball court fees and Open Play fees are included with membership.
  - Pickleball lessons are additional fees.
- ❖ *What are the beginning and end dates for the membership year?*
  - September 1 through August 31. All memberships will automatically renew each year on September 1<sup>st</sup> unless resigned.
- ❖ *May a member join for a period of time less than the 12 month contract?*
  - Membership begins on the day in which the member application was signed through August 31<sup>st</sup>. General Manager has discretion in cases of serious injury or illness as well as instances in which an out of the area move is required.
- ❖ *May a new member join at anytime?*
  - Absolutely. Membership would be valid and binding beginning on the date in which the member application was signed through August 31<sup>st</sup>. Dues will be prorated accordingly for the first month of membership.
- ❖ *Is access to the Batting Cages included with a Hitters Pickleball Club membership?*
  - It is not included. Tokens may be purchased at the front desk.
- ❖ *Can parents play with their children on the courts?*
  - Yes, but they must be registered as a guest if they are not a member. Each guest may play up to 5 times per year at a cost of \$10.00 per visit.
