- ❖ Membership is valid and binding for one year beginning on September 1st, 2021 or on the date of completing the membership application through August 31st, 2022. All memberships will automatically renew on September 1st of each following year until membership is resigned by emailing the GENERAL MANAGER at: joel@hitterstennis.com by August 31st of the current year. If member fails to resign membership by August 31st, member will be liable for all membership dues for the following season which runs from September 1st through August 31st of each year.
- ❖ A re-instatement Initiation Fee will be applied to returning members who have previously resigned in the amount of the following:
10U Members \$100.00, Junior Single \$300.00, Adult Single \$300.00, Adult Senior \$300.00, Couples \$500.00, Families \$750.00

Frequently Asked Membership Questions

- ❖ *What is included in a Hitters Tennis Club Membership?*
 - Access to open court time at no charge as well as exclusive access to our lesson and league program.
 - Adult, Senior, and Family Members have full access to Hawks Landing Tennis & Pickleball Club lesson programs.
 - Access to our Cardio Fitness Area.
- ❖ *Do I need to be a member to take lessons?*
 - Yes. The only exception is our Adult Beginner lessons offered on Tuesday and Saturday.
- ❖ *Is PICKLEBALL Included with membership?*
 - Yes, all Pickleball court fees and Open Play fees are included with membership.
- ❖ *What are the beginning and end dates for the membership year?*
 - September 1 through August 31. All memberships will automatically renew each year on September 1st unless resigned.
- ❖ *May a member join for a period of time less than the 12 month contract?*
 - Membership begins on the day in which the member application was signed through August 31st. General Manager has discretion in cases of serious injury or illness as well as instances in which an out of the area move is required.
- ❖ *May a new member join at anytime?*
 - Absolutely. Membership would be valid and binding beginning on the date in which the member application was signed through August 31st. Dues will be prorated accordingly for the first month of membership.
- ❖ *Is access to the Batting Cages included with a Hitters Tennis Club membership?*
 - It is not included. Tokens may be purchased at the front desk.
- ❖ *Can parents of junior players play with their children on the courts?*
 - Yes, but they must be registered as a guest if they are not a member. Each guest may play up to 5 times per year at a cost of \$15.00 per visit.
- ❖ *What type of Court Time is included with membership and how often can members book a court?*
 - Each member may reserve up to 1.5 hours of tennis court time per day when available.
 - Pickleball courts may be reserved for up to 2 hours per day when available in addition to Open Play.
- ❖ *What is the ball machine policy?*
 - Members have access to our state of the art ball machines.
 - Fees: One time use \$5.00, Annual Unlimited Single \$50.00, Annual Unlimited Family \$100.00.
 - Court Fees are included at no charge with ball machine.
