If member fails to resign membership by August 31st, member will be liable for all membership dues for the following season which runs from September 1st through August 31st of each year.
- A re-instatement Initiation Fee will be applied to returning members who have previously resigned in the amount of the following: 10U Members \$100.00, Junior Single \$300.00, Adult Single \$300.00, Adult Senior \$300.00, Couples \$500.00, Families \$750.00

- **What is included in a Hitters Tennis Club Membership?**

- What are th beginning and end dates for the membership year?
 - September 1 through August 31. All memberships will automatically renew each year on September 1st unless resigned.
- May a member join for a period of time less than the 12 month contract?
 - Membership begins on the day in which the member application was signed through August 31st. General Manager has discretion in cases of serious injury or illness as well as instances in which an out of the area move is required.
- **May a new member join at anytime?**
 - Absolutely. Membership would be valid and binding beginning on the date in which the member application was signed through August 31st. Dues will be prorated accordingly for the first month of membership.
- Can parents of junior players play with their children on the courts?
 - Yes, but they must be registered as a guest if they are not a member. Each guest may play up to 5 times per year at a cost of \$17.00 per visit.
- What type of Court Time is included with membership and how often can members book a court?
 - > Each member may reserve up to 1.5 hours of tennis court time per day when available.
- What is the ball machine policy?
